Provides consultation, evaluation planning and progress monitoring for the JCPS Behavior Support System. Coordinates practices and procedures for the implementation of the Behavior Support System.

Provides leadership to schools and teacher leaders in the areas of Positive Behavior Interventions Supports and other research based behavior support strategies

Consults with school staff and district leaders in the design of multi-tiered support systems to decrease behaviors in schools

Coordinates the implementation of the district and school; based MTSS plans, supporting individua school needs as they arise

Provides leadership to schools and teacher leaders in the area of Restorative Practices (RP) strategies and implementation

Develops, establishes, and administers training to schools and district role groups to ensure the best practice strategies are being used in all spaces of the district

Makes recommendations regarding school culture program implementation, and evaluates to ensure effectiveness

Consults with school staff and district leaders in the implementation of school-based, wall to wall, implementation of RP

Maintains communication and works closely with District staff, local school staff, and the community to ensure school culture programming is aligned, consistent, and implemented with fidelity

Supervises and progress monitors school culture and behavior related plans and provides feedback to district leaders to assist them in their roles

Evaluates effectiveness through data analysis and utilization of district reporting mechanisms to coordinate resources for school

Performs other duties as assigned by supervisor
